NETWORK UPDATES

Be sure to get updated insurance ID cards on all patients. With many insurance changes, the ID card is your first point of verification. If you have any questions about any of the network changes below, please contact our office at 888-635-0459.

SuperMed - Effective January 1, 2015, Medical Mutual or SuperMed will no longer be in Georgia so the contract with them will be terminated.

Memorial Health Partners - Memorial Health Direct (MHD) is an innovative and locally developed health benefit plan and supporting provider network being offered by Memorial Health Partners to serve the unique needs of Savannah's small employer groups. MHD is being sold in Chatham, Effingham, Liberty, and Bryan counties. For more information, contact (877) 342-0280.

Coventry Health Care and other carriers - Activ will continue to be Coventry's chiropractic network for 2015. However, there will be many changes in insurance benefits. The changes, prompted by the Affordable Care Act, will include much higher deductibles on many policies which will be applied prior to the co-payment being applied. Be sure to verify benefits and collect the proper amounts for patient responsibility.

Online coverage verification - Activ typically receives a new eligibility data file from Coventry around the 10th of each month. Many policies will have changes in benefits effective 1/1/2015. In order to avoid giving the incorrect benefits during the first couple of weeks of 2015, Activ will suspend its online coverage verification tool until we are confident the data is reflecting the 2015 benefits. The suspension will begin 12/30/2014.
